## INSTALLATION INSTRUCTIONS

### PIPE MOUNT INSTALLATIONS

1. Place shells together around pipe stanchion and match edges evenly.
2. Clamp the shells together with vise grips, c-clamps, or binder clips on both sides for ease of rivet installation.
3. Insert a plastic rivet through each hole and press firmly until it snaps.
4. Continue to positioning clamp installation.

### POSITIONING CLAMP INSTALLATION

1. Once shells have been installed around the pipe, affix the positioning clamp to the pipe stanchion below the shells.

2. Adjust the shells to the desired height and hand-tighten the positioning clamp flush with bottom of the shells.
3. Use pliers or vise grips to further tighten the positioning clamp.

### WALL MOUNT INSTALLATIONS

1. Secure half shell to wall using either screws or rivets (supplied by others) through shell edge or holes, or double-sided adhesive tape or appropriate sealant. Apply to flat area (outer flange) for best results.
